Hitachi Metals Changes Representative Executive Officers and Executive Officers

Hitachi Metals, Ltd. hereby announces several personnel changes involving representative executive officers and executive officers decided at a board of directors meeting on May 27, 2020.

1. Reason for the Changes

The Company announced in "Misrepresentation of Test Results in the Inspection Reports with Respect to Certain Products of the Company and Its Subsidiaries" dated April 27, 2020 that it had initially discovered conduct including misrepresentation of test results in the inspection reports submitted to customers of some of the specialty steel products and the magnetic material products (ferrite magnets and rare earth magnets) manufactured by the Company and its subsidiaries. Following the announcement, the Company established a special investigation committee comprising outside experts on April 27, 2020 and the committee is currently conducting an objective investigation into the facts and root cause of the matter. At the same time, efforts to enhance the quality assurance system are being made by the Company, including by its internal task force in charge of the matter.

Furthermore, the Company is making every effort to further improve its management, including its organization and control system, and to ensure objectivity and fairness in the investigation into the facts and root cause of the matter, and in the examination and implementation of the measures to be taken to address the matter in light of those findings. For these purposes, the Company decided to change the members of the management team. The president and other executive officers, as well as a director who was previously the president of the Company, will resign as of May 31, 2020. In addition, the current chairperson will assume the position of the president for purposes of expediting the Company's decision making, and a new executive officer will join the new management team as of June 1, 2020.

Under the new management team, the Company will endeavor to prevent a recurrence of such matter and to regain its customers' trust including by conducting a thorough investigation into the facts and root cause of the matter, fundamental review of its quality control system and further enhancement of its compliance framework.
